Horace Pierce Mallory - Jacksonville, Florida

Horace Pierce Mallory, 85, of Jacksonville, Florida passed away Saturday, April 15, 2006. He was a loving husband, father, grandfather, and great-grandfather. Pierce was a Lieutenant Commander in the United States Navy. He proudly served for thirty-one years before retiring. His service included World War II, the Korean Conflict, and Vietnam.

Pierce was preceded in death by his parents, Horace Pierce Mallory, Sr. and Georgia Vickers Mallory. He is survived by his loving wife, Virginia Barbara Hardy Mallory; daughters, Laura Melton, and Joan Langston (Alan); grandchildren, Amy Wilkinson (Randy), and Michael Langston; and great-grandchildren Ryan, Amanda, and soon-to-be Tyler Wilkinson.

Pierce had cancer and was undergoing treatment. His email messages were always happy and upbeat. He had a stroke the morning of April 15th and he died in his sleep, with his family at his side. He will be greatly missed.

Hawes DNA Study Update

The Hawes ancestry of Bentley Hause of Cameron, Milam County, Texas has been discovered. At least that is my belief. Records have been ordered from two Georgia counties that will hopefully confirm this. He is believed to be a descendant of Isaac Hawes, Sr...

Bentley Hause has known his family's line back to his ancestor, Barnett Haws, born in Georgia, for a long time. The 1830 United States Census showed Barnett in Clinton, Jones County, Georgia, at the age of 20 to 30; and in his household, a female [wife] 15 to 20; and one male child under 5.

There is other information that is known about Barnett Haws, a few of those items follow. He married Lidia "Siddy" Shurley on August 20, 1828, in Jones County, Georgia; he participated in the Georgia Cherokee Land Lottery, 1832, in Jones County; and when his estate was probated in Macon County, Alabama in 1854, he was survived by his wife and children. His children were named in his will; Monroe Haws, over 21; Guss Haws, over 21; Ann Hill, wife of James Hill; Emmaline Dismukes, wife of Jefferson Dismukes; and the following minor children; Nathaniel Haws, Sterling Haws, Thomas Haws, William Haws, Victoria Haws, Americus Haws, and John Haws.

Claiborne Hawes, Richard Hawes, and Newton Hawes, three of the sons of William & Elizabeth Hawes were in the Baldwin County and Jones County areas of Georgia, where Barnett started his family. I suspect that one of them is Barnett's father. Claiborne married Sally "Dicey" Pickett; this is known from a record of their marriage on May 3, 1812, and his will probated in 1826. Both their marriage and his will occurred in Baldwin County, Georgia. Sally remarried in 1827 to Hope Hull Slather/Slatter; a year later Barnett married.

Claiborne is shown as the head of household for a large family, in Baldwin County, Georgia, with about 16 slaves, in the 1820 United States Census. Although only married for about eight years, the household included a boy under 10; a boy between 10 & 16; two men between 18 & 26; one man between 26 & 45; two females between 18 & 26; and one female age 45 & up. It appears to be a combined family. I hope the records that have been ordered from the county will offer some answers.

Mr. T. J. Hawes of Gainesville, Florida, with the help of our association member Mary Knight, did research almost twenty years ago, that showed Charlotte Gay was the wife of Richard Hawes above, and listed their descendants. Barnett was not their child. There is little know about Newton Hawes, other than we know that he participated in the Georgia Land Lottery of 1827, was shown as a soldier, and that the land he gained in the lottery was in the same section as land "drawn" by Betsey Pickett (the mother of Claiborne's wife). I cannot find Newton, on the 1820 or 1830 censuses.

Bentley Hause's DNA test results confirm that he is a descendant of our first Samuel Hawes of Virginia, because his results match almost perfectly proven descendants; Joe D. Hawes, Richard Simrall Hawes III, and William E. Hawes (descendants of Samuel Hawes II), and Jesse N. Hawes, Jr. (descendant of Isaac Hawes, Sr.). Plus Bentley matches Raymond Jerry Hawes, for whom we have no paper trail that connects Ray's James W. Hawes and Samuel Hawes I. We just have DNA matches. (Continued on page 5... DNA)

Below is what I believe to be Barnett Haws' family line, down to but not including him. To save space, I am including only the male line. Caroline County was created in 1727, from other Virginia counties, including a part of Essex County.

Samuel Hawes I - (circa 1675- circa 1765); born unknown; died Caroline County, VA

Samuel Hawes II - (1727-1794), born & died, in Caroline County, VA

Isaac Hawes, Sr. - (circa 1718-1789), born & died, in Essex County, VA

Samuel Hawes - (circa 1739-1786), born & died in Essex County, VA

William Hawes - (circa 1762-1801), born in Essex Co., VA & died in Lincoln Co., GA

- ** Claiborne Hawes (circa 1785-1826), born unknown; died in Baldwin County, GA
- ** Claiborne is one of the children of William Hawes; William's other children were Burton, Richard, Newton, & Betsey.

If any of you have additional or different information, concerning any of those above, it will be greatly appreciated. I will find a way to reward you.

LAND RECORDS CAN TELL A STORY

Land records can tell a story, but what is it? I have abstracts of three Samuel Hawes land transactions and one tax record that will appear below, from Virginia records. I will identify the correct Samuel for each transaction, to the best of my ability. In addition, and not having anything to do with land records, I will furnish the names of the first Caroline County, Virginia Committee of Safety. It includes two persons named Samuel Hawes and a few other surnames familiar within our family.

Samuel Hawes is a name that appears many times, in our family, especially in our family's early years in Virginia. Our first known Hawes ancestor in Virginia was Samuel (circa 1675-1769) (married to Elizabeth Anne Spencer); they named their first son Isaac (circa 1718-1789), and named their second son and youngest child Samuel (1727-1794). Both Isaac and Samuel named their first born sons, Samuel.

At this point, I will refer to Isaac as Isaac Hawes, Sr., and to Samuel as Samuel Hawes II. But, I will tell you that Samuel Hawes II was at first known as Samuel Hawes, Jr., and then later when the first Samuel Hawes was older and no longer doing business, Samuel Hawes II dropped the Jr., in Caroline County records, and his son began using Jr... Confusing? Yes.

Isaac Hawes, Sr., when he married, lived in Essex County, VA and raised his family there. His son Samuel is rarely confused with the Caroline County Samuel Haweses, because of that.

The elder Samuel Hawes (1st), we believe lived at "Woodpecker", in Caroline County, at the home of his son, Samuel Hawes II, in his old age and until his death.

Most descendants of Isaac Hawes, Sr. left their Essex County, Virginia homes and migrated south to Lincoln County, Georgia and the Edgefield District of South Carolina, in 1797. Most of the descendants of Samuel Hawes II migrated to Kentucky, in 1810.

Virginia Land Transactions:

First: Date recorded February 4, 1745, in the name of Samuel Hawes; location Spotsylvania County; 316 acres. This property was originally part of a patent granted to Robert Coleman of Drysdale Parish, Caroline County, on December 2, 1723, and had been transferred by Deed of Gift to his son, John Coleman. [John Coleman is the same John Coleman, Sr., whom married Eunice "Nicey" Hawes in about 1751, daughter of our first Samuel Hawes.] The Samuel Hawes in this first transaction is our first known ancestor in Virginia, her father. Note: Robert Coleman, of King & Queen County, VA, with the original patent mentioned here, named his first child, born April 27, 1704, Samuel Hawes Coleman. Was Samuel Hawes an old friend? Or was there another connection, in an earlier generation, for which we have no record.

Second: Date recorded May 1, 1752, in the name of Samuel Hawes, Jr.; location Spotsylvania Co.; 278 acres in St. George Parish, Spotsylvania. This land came to Samuel Hawes, Jr. after the mother of his new bride died. Anne Aylett married first Benjamin Walker, the eldest of their four children was Ann Walker, whom married Samuel Hawes, Jr., in 1752; Benjamin Walker died in 1738; Anne Aylett Walker, his widow, married second Rice Curtis, Jr... When Anne Aylett Walker Curtis died, this property became a part of the settlement of her estate, after a lawsuit was filed. This Samuel Hawes, Jr. is Samuel Hawes II; his son was not born until two years later.

Third: Land/property on the Tax list, in 1783, belonging to Samuel Hawes, 6th district, Essex County, Virginia, appearing on page 52, of the Virginia Early Census Index. This is Samuel Hawes, the first son of Isaac Hawes, Sr.

Fourth: Date recorded December 6, 1785, sold by Samuel Hawes of Caroline County, 370 acres in Spotsylvania to Peter Mason and his wife, for 296 currency. I believe that this was Samuel Hawes II.

Caroline Committee of Safety was formed on November 10, 1774, under the Eleventh Article of the Constitution adopted by the Continental Congress. Voters of each county elected twenty of their leading citizens. Those first elected to the Caroline County Committee of Safety were: Chairman, Edmund Pendleton; James Upshaw; William Woodford; Richard Johnston; Thomas Lowry; Benjamin Hubbard; Thomas Lomax; John Minor; John Armistead; Edmund Pendleton, Jr.; Clerk, Samuel Hawes, Jr.; William Nelson; George Baylor; George Taylor; John Jones; Anthony Thornton; John Tennant; George Guy; Samuel Hawes; and Walker Taliaferro.

Samuel Hawes, Jr., Clerk of the Committee of Safety, was also a member of the Caroline County Militia. At the outbreak of the Revolutionary War, at age 21, he left the Committee of Safety to go to war. He rose to the rank of Lt. Colonel, serving until the Revolutionary War ended. This Samuel Hawes, Jr. (1754-1788) was the son of Samuel Hawes II, and he never married. He is said to have suffered ill health for the balance of his life, after the war; he died in Caroline County, Virginia, at the age of 34. The other Samuel Hawes on the Committee of Safety was Samuel Hawes II, his father.

Our First Know Hawes in Early Virginia

SAMUEL HAWES was born Abt. 1675, and died Abt. 1769 in Caroline County, Virginia. He married ELIZABETH ANNE SPENCER Abt. 1717 in Virginia, daughter of THOMAS SPENCER. She was born Abt. 1692, and died Abt. 1753 in Caroline County, Virginia.
