



ITEM, I live [leave] to my Son Frederick Coghill the Plantation whereon I now Live after my Dices [Decease] to him and his heirs forever. ITEM, I live to Suanner Miller Ten Pounds Current money. Children to them and theres forever. ITEM, It is my Desire that Negro Moll & Negro Nedd that now Living at James Corkitt shu'd be William Samuell the son of Sarah Corkitt To him and his heris [heirs] Layfolly Begotton of his Boddy forever and if he shud Dey without heirs then to Return to James Corkitt and his heirs forever Lawfully Begotton of his body ITEM It is my Desire that Cate and all her Increase shu'd belong to James Corkitt and his Wife as Long as they shall Both Shall Live and then shall be Equally Divided amonks James Corkitt Children to them and their heirs forever. It is my Desire that Thomas Coghill and Frederick Coghill to be my Exter [Executor]. In Will and Testament all wherin I do have this my Last Interchanable Set my hand & Seale this 12th Day of October 1758.

HAWES - COGHILL

A few years ago, one of the Coghill descendants sent me a copy of the book, "The Family of Coghill 1377-1879. With Some Sketches of Their Maternal Ancestors, The Slingsbys, of Scriven Hall 1135-1879 by James Henry Coghill". On page 105, of that book, the spouse of our Elizabeth Hawes (daughter of the first Samuel Hawes) was named by an elderly Coghill descendant. He said that if his memory served him correctly, he was Frederick Coghill, Jr.. The spouse of Elizabeth Hawes was named by Elizabeth Hawes Ryland in "Hawes of Caroline County, Virginia" as Thomas Coghill. She stated that their descendants still reside in Caroline County. Thomas Coghill and Frederick Coghill, Jr. were brothers and both of them are named in the will of Frederick Coghill, Sr., their father. I do not know which of the brothers were married to our Elizabeth Hawes, but I do not have enough evidence at this time to change the information from Ms. Ryland's book.

Last year R.L. Samuell sent me a copy of the transcript of the will of Frederick Coghill, Sr. and the division of his estate appearing on pages 3 & 4, of this newsletter. One of the five children / beneficiaries named was Mary Haws, spouse of Isaac Haws. Mr. Samuell believed that two of the children of Samuel & Elizabeth Anne Spencer Hawes married into this Coghill family.

Molly's & my visit to the Tappahannock, Essex County, Virginia courthouse this year allowed us to view the original county will record and verify the transcript. The information is accurate. The husband of Mary Coghill was Isaac Hawes, in my opinion Isaac Hawes, Sr., the oldest child of Samuel Hawes I. I've read and reread Ms. Ryland's information and I do not believe that there is a conflict.

This is the family of William Franklin Hawes, Sr. The census shows his real estate valued as \$11,500 and his personal wealth as \$16,335. They resided in Hawesville, Hancock County, Kentucky. He was the youngest son of Richard & Clary Walker Hawes. His oldest son, Wm. Franklin, Jr. married Anne McAdams on January 9, 1860, so was not a part of this household at the time of the census.
