Current updates to the earliest emigrants to the new world concerning the Virginia/Tennessee/Kentucky/Texas line of the Hawes Family:

Unfortunately, there is very little new information to pass along. Due to wars, courthouse burnings and lack of organized record keeping in the late 1500's and early 1600's, most positive trails, leads, and ACTUAL documented information tends to vanish in thin air. So much online information available to the general public has been tainted to the point that no information can be taken for granted, and must all be documented. Some having to proven by DNA testing.

I have, however, found a possible father and grandfather of a Reginold (Reginoll-Reginell), Hawes that has been seen in passenger lists coming across on the Bonaventure in 1635. He was shown to be 25 yrs old at the time, which gives him a birth year of approx. 1610. This is a lead I will have to investigate more and hopefully open a new path to pursue.

Along with this is a Thomas and John Haweis (spelling also used during that era), that needs to be tracked. David and Nicholas Haweis also enter the picture in the late 1500's. I still have a lot of work to do, but feel confident we will connect the dots between the old and the new world. Hopefully, I will have more info to give out at the Family reunion!

In the past, we have honored early founding members of the family, their historical, military and government accomplishments through their long lives. This year I would like to change that a bit and add a page to recognize family members that continue the great history of the Hawes family!!! I received a very nice letter from Faye Morgan I would like to publish. Since it was written by hand and may be a little difficult to read, I have typed it out to make it a bit easier to read. I hope more family members continue to send in interesting additions from their family's past.

Anna Marie Hawes Moore (1896-1968)

Anna had two daughters Rose and Mary Virginia. Rose passed away as an infant. Mary Virginia became a child model, actress and ballet dancer in Chicago.

Mary graduated from Senn High School with honors and married W.L. Morgan soon after. They were blessed with two wonderful children, Wally and Patsy. When Patsy was only a few weeks old, Mary Virginia died with Leukemia. Anna Marie assumed caretaker of Wally and Patsy for many years.

When W.L. Morgan, II married Elizabeth Talbot of Atlanta, Anna took Wally and Patsy several weeks later to be with their father in Atlanta. They asked Anna to live with them because they did not want to separate Grandmother Moore from the children. Anna continued to live with them for ten years in Atlanta.

At age fifteen, Wally went into the U.S. Army. At age fourteen, Patsy married James Sasser. Anna moved back to Chicago where she had two sisters. Patsy finished high school and became a nurse, graduating with honors. Wally stayed in the U. S. Army for twenty-one years in the 101st airborne, Rangers, and the Golden Knights Army Parachute Team.

Anna had a few years break from being a nanny until Jimmy and Patsy asked her to come and live with them and their two children, Donna and Butch in Baltimore. Anna now took care of her two great grandchildren for several years.

Anna was a very talented lady, generous and caring, who put her family above her own desires of a career and marriage. We all cherish Grandmother Moore's memory, her love, devotion and sacrifice to her family! Our lives have been greatly blessed by Anna Marie Hawes Moore.

Hawesville founder died in year county was born

Some very interesting information has been made available to the Clarion concerning Richard Hawes, the man who donated the site upon which Hawesville was established. The information consists of genealogical notes, an excerpt from a History of Daviess County and the wills of Richard Hawes and his wife, Clary Walker Hawes.

Richard Hawes was born in Virginia in 1772. Clary Walker was a native of Virginia, also, born August 1, 1776. The couple became man and wife in February, 1792, the year Kentucky gained statehood.

According to the historical account, they came to Fayette County, Ky., in 1810, and soon relocated near Louisville. They continued to live there for 10 years, until 1820, then moved to the vicinity of Yelvington in Daviess County. Hawes acquired large tracts of land in both Daviess and Hancock counties, and a part of the land here was donated as the site for Hawesville.

The history says Hawes was an energetic man, who amassed a fortune. He gave employment to many people and was favorably regarded in both counties as a kind employer and a respected citizen. He died in 1829, his will being recorded in the Daviess County records. The will of Clary Walker Hawes was recorded in 1847, and she died the following year, 1848.

The history said they had 10 children, but the family history credits them with 12. The ones named in the family history are also mentioned in the will of Richard Hawes, whereas the historical item does not name them correctly. The children and their birthdates are as follows: Ann Hawes, January 27, 1793; Samuel Hawes, June 14, 1795; Richard Hawes, February 6, 1797; Hugh Walker Hawes, October 20, 1798; Kitty Walker Hawes, October 17, 1800; Aylette Hawes, January 12, 1803; Albert Galaton Hawes, April 1, 1806; Edwin Hawes, October 24, 1807; Benjamin Walker Hawes, April 19, 1810; Clara Mary Hawes, October 28, 1811; Susan Elizabeth Hawes, October 28, 1816; William Franklin Hawes, April 28, 1819.

The information was loaned to the Clarion by Mr. J.E. Buck of Hawesville. The Hawes wills are reproduced below.

distributions to wit. That my Executrix and Executors shall visit the whole of the debts due me over and above what may be necessary for the support and education of Wife and children in negroes as fast as the debts can be collected and the negroes so purchased to go to the possession and use of my wife as the negroes which I now possess. I give to my son Samuel Hawes the part of our thousand acre lot as laid off for him containing Three Thousand and Fifty Eight acres, and to my son Hugh Walker Three Hundred and Forty out of the same lot and adjoining on the lower side as laid off by Captain Johnson--I give to my daughter Kitty five hundred and fifty acres lying in Hancock County as laid off by Captain Johnson on which John J. Coleman lives. I give to my son Albert seven hundred acres beginning at Kitty's upper corner on back line thence with his line to the river thence up the river to the lower end of town thence out to the back line of town and thence to the back line, thence to the beginning so as to include Seven hundred acres. I give to my son Edwin five hundred acres beginning at Kitty's lower line on the river thence down the river to Mrs. Adams line thence out from the river with her line so far as that line remains parallel with the river line will include five hundred acres. I give to my daughter Nancy four hundred acres in the tract of one thousand acres opposite Rockport lying on the upper side and running from the river to the back line so as to include the quantity. I give to my son Albert the negroes Anna, Sam. Mary, Sarah, Jenny, Absalom, Joe.

Marie and Esther. I give to my son Edwin Ned, Washington, Sally, Juliett, Nancy, Tom, Anna, Nelly and Charles. I give to my son Benjamin the tract of land adjoining Walker's on the lower side supposed to contain four hundred and thirty nine acres being the balance of the tract which Sam and Walker own. I give to my son Aylett four hundred and fifty acres of land adjoining that given to my daughter Nancy on the lower side and laid off in the same way as Nancys. I wish my wife to allot to Benjamin, Susan and William as many negroes as have been given to my other children as soon as they marry or become of age. I have already given to my daughter Kitty two thousand five hundred dollars instead of negroes and to my son Aylett the same. My son Aylett to be charged with five hundred in addition because of the extra expense in education and three hundred dollars to be allowed Benjamin because his education has been so much less expensive. My wife will also give each as

much personal property as the others have had. My wife shall have Susan and William well educated out of the estate and they together with Albert, Edwin and Benjamin to be clothed, boarded until each shall receive his distribution that the others have had. My wife, if she chooses, may make an additional distribution of negroes to the children if she shall wish to do so. In case of my wife shall marry it is my will that instead of the whole as before mentioned she shall have one half for life only. Lastly I appoint my dear wife Clara Hawes executrix and my sons, Samuel, Richard, Albert, Edwin and Benjamin my Executors to this my last will and testament. All money due by any of my sons and sons-in-law to me to be paid to the estate or considered as a part of their dividend at the option of my wife. The appointment of Executors not to operate as a relinquishment of their debt. I owe no debts. I don't wish my Executrix or Executors to give security for their Executorship. All whatever has been heretofore given and is given by this will shall be considered as so much of their shares of the estate except the three hundred dollars to Benjamin and the extra five hundred dollars to be charged to Aylett in the same way and it is clearly my will that all my children may be made equal in the distribution of my estate. Hereby revoking all wills made by me. In testimony whereof I have set my hand and seal this 12th day of November 1829.

The words "her line" were interlined before signing this will.
